To obtain documents from financial institutions, by far the easiest way to get them is to get a consent from the customer. With the consent the institution will even give you a business records affidavit.

Otherwise, you must follow Tex. Fin. Code 59.006 to the letter. If you do not, the financial institution can ignore your subpoena and the court is prohibited from signing an order compelling the institution from producing them. If you are unable to obtain consent, here's the application I drafted for such records (make sure you read 59.006(c) and (d) carefully). And you need to start the process early.

This subpoend has been served on the customer per Tex. Rule Civ. Proc. 21(a) and the customer bears the burden of preventing or limiting the financial institution's compliance with a record request subject to this section by seeking an appropriate remedy, including filing a motion to quash the record request or a motion for a protective order. Any motion filed shall be served on the financial

institution and the requesting party before the date that compliance with the request is required. A financial institution is not liable to its customer or another person for disclosure of a record in compliance with this section;
