1. Gain Criminal Defense Legal Experience:

2. Fulfill Certification Requirements:

Become board-certified in criminal law: The Texas Board of Legal Specialization offers certification in criminal law. While not mandatory, obtaining certification demonstrates a high level of competence in the field and can enhance your credibility in handling capital cases.

3. Meet Texas Capital Defense Standards:

Familiarize yourself with the Texas Capital Defense Standards: The State Bar of Texas and the Texas Court of Criminal Appeals have established standards for attorneys handling capital cases. Familiarize yourself with these standards to ensure compliance.

The Listerserv allows you to see what discussions are held and the committee keeps you updated on relevant laws and issues.

7. Trial Experience:

Gain trial experience: Handling capital cases often involves complex trial proceedings. Build your trial experience by participating in criminal trials and deeply understanding courtroom procedures. Ask to sit the second chair to our TCDLA members on the capital listserv or a colleague.

8. Mitigation & Investigation:

Understand the skills and team members needed for mitigation and investigation: Mitigation is a crucial aspect of capital defense, involving presenting evidence to mitigate the severity of the punishment. Know what is necessary to investigate and present adequate mitigation evidence.

9. Seek Appointments:

Apply for appointment in capital cases: In Texas, attorneys are often appointed to represent defendants in capital cases, mainly if the individual cannot afford legal representation. Contact the local public defender's office or the regional capital habeas unit to express your interest in handling capital cases and determine the requirements.

10. Get a mentor: TCDLA has a mentor program designed for those wanting to get involved with capital defense.

11. Stay Informed About Death Penalty Laws:

Stay updated on death penalty laws: Keep abreast of changes in death penalty laws, court decisions, and legal developments in Texas. This knowledge is essential for providing effective representation.
