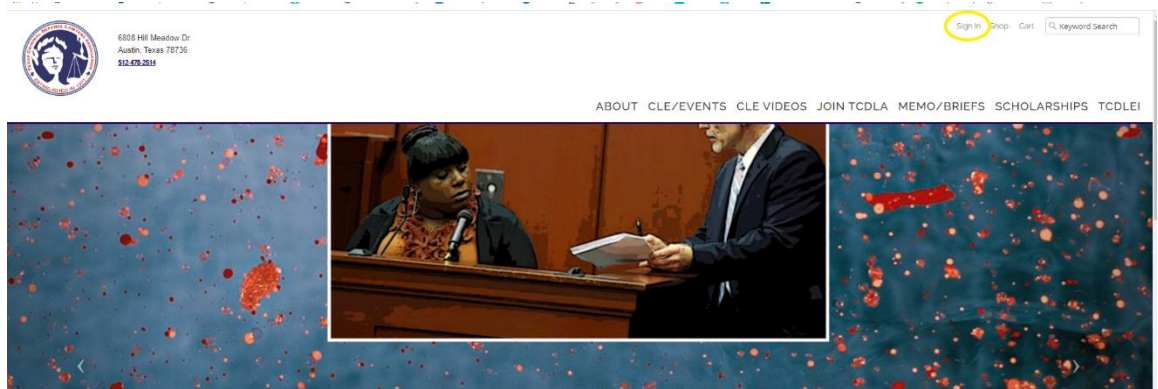


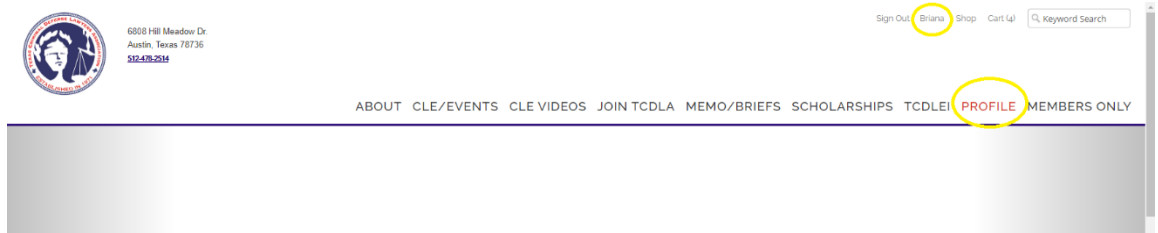

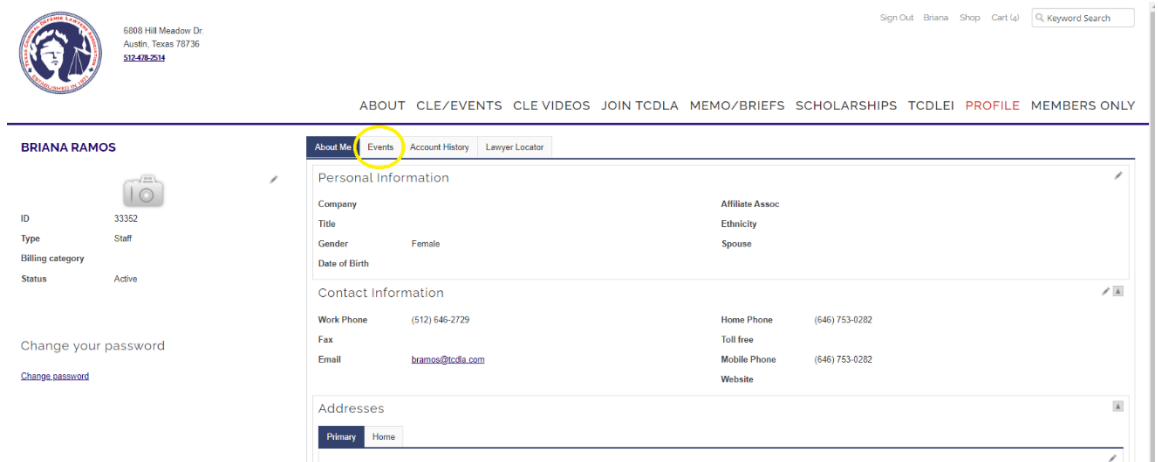

How to Access Event Materials

UPCOMING EVENTS = Today is Prior to Event Date

If the event start date equal to or greater than today's date, scroll down to "Upcoming Meetings and Events" and select the event you'd like to view materials for (circled in red)

PAST EVENTS = After the Event Date

If the event start date is less than or equal to today's date, scroll down to "My Past Events" and select the event you'd like to view materials for (circled in blue)
