

FREE Juvenile Defense Training Immersion

Multiple locations – 2021-2022: 3.0 CLE

Overview

TCDLA has partnered with the Texas Indigent Defense Commission (TIDC) and National Juvenile Defender Center (NJDC) to present a series of juvenile defense training programs for attorneys who represent indigent clients. The training is presented in a highly interactive, small-group format by experienced attorneys who have been certified in NJDC's Juvenile Training Immersion Program (JTIP).

These programs are funded by a grant from the Office of the Governor of Texas and the U.S. Department of Justice. There is no cost to attend, and participants may apply for a stipend to cover travel expenses.

This training series includes six in-person events around the state. Masks will be mandatory for people who are not vaccinated and recommended for people who are. The series will also include webinars.
